

# 2026 Spring Crappie Classic

## Fishing Tournament Entry Form

Saturday, March 28th, 2026 at Alamo Lake

### **Rules:**

- 1) All State of Arizona, Arizona Game & Fish Department, Alamo Lake State Park, and United States Government laws and regulations must be followed. Failure to comply with said laws and regulations along with the rules of this event might result in forfeiture of any money paid and disqualification from the event.
- 2) This event does not include parking or camping fees. Everyone is responsible for obtaining the appropriate pass.
- 3) Signed tournament entry forms with rules and regulations will be taken at the Group Camp 1 area. Entrants will receive a boat number and tag after check-in, Present this tag to Weigh Master at weigh-in. Live well checks will start at 4:30am. Once this is done, entrants may go launch their boat but, must stay inside the buoys and not start fishing. Designated release time will be \_\_\_:\_\_\_ am to start fishing. Time will be designated at Check-in. (approx 6:15am)
- 3a) If participating in Let's Talk Fishin (LTF) Crappie tournament, follow LTF and live well check rules. AZCA will accept LTF live well checks.
- 4) Heaviest bag of 7 Crappie per team wins. You will be allowed to keep all the fish legally permitted but you can only weigh in 7 Crappie. All Crappie weighed and/or kept at this event must be at least 10 inches in length. Any Crappie caught smaller than 10 inches must be immediately released. In case of a tie on total weight, the weight of the largest crappie will be used to break the tie.
- 5) A 4-pole limit per team, you can have up to 4 people on your team but only 4 poles in the water at a time. One team per boat.
- 6) Hook and line, live bait and trolling are permitted.
- 7) Encroachment — a "25" yard rule is always in effect during competition. No contestant's boat may move within 25 yards of another contestant's boat at any time for the purpose of fishing unless initial party has granted permission. A boat moving from one area to another may not "tie-up," "claim," or "protect" more than a single dock or location at one time regardless of the distance involved. Pictures or videos should be taken and given to the tournament director. Encroachment can be grounds for disqualification. Left up to the tournament director.
- 8) Total entry fee is \$75 (exact change, cash only), where \$60 of that fee per team is paid back to the tournament entrants for 1<sup>st</sup> place (33 1/3%), 2<sup>nd</sup> place (20%), 3<sup>rd</sup> place (13 1/3%), and Wild Willie Biggest Crappie (33 1/3%). \$15 of that fee goes back to the Arizona Crappie Association and helps pay for event liability insurance, trophies, and other costs associated with the fishing tournament and are not paid back in tournament winnings
- 9) Weigh-In, entrants must weigh in at Group Area 1 parking lot. Weigh-in scales will open at 2:00pm, anyone not in Cholla Ramp Buoys by 2:30 could be disqualified. Designated weigh in time is 3:00pm, this will be a drive through weigh-in conducted by LTF. When approaching the scales for weighing please have fish bagged and big fish tagged. When presenting fish to be weighed, they immediately become the "official catch" of the contest, and they become the possession of the Weigh Master to measure, weigh and record as such. Big fish should be tagged to help identify the big fish quickly.
- 10) The announcement of tournament winners and presentation of trophies for AZCA Spring Crappie Classic will occur at the Alamo Lake Group Area 1 following LTF announcements.

**RELEASE AND EXPRESS ASSUMPTION OF RISK AGREEMENT**

In consideration to participate in any way in the event on the reverse side, I agree and acknowledge:

**1. Release:** I personally and on behalf of my heirs, successors, servants, assigns, executors, administrators, guardians and conservators, HEREBY, DISCHARGE, CANCEL, WAIVE, COVENANT NOT TO SUE, ACQUIT AND HOLD HARMLESS the State of Arizona, the Alamo Lake State Park, the United States Government, the Arizona Crappie Association, and its partners, employees, principals, agents, servants, heirs, administrators, successors, shareholders, directors, officers, representatives, and attorneys. As well as any governmental entity where the Events are held, and agree to hold them free and harmless for, from, against any character whatsoever, whether known or unknown, suspected or unsuspected, arising from their negligence or otherwise, including but not limited to, all liabilities for personal injury, property damage or wrongful death caused by such negligence or otherwise (the "Claims").

**2. Indemnification:** I also agree to indemnify and defend the Arizona Crappie Association, the State of Arizona, the Alamo Lake State Park, and the United States Government against the claims, and other damages, costs and expenses, including reasonable attorney's fees, resulting from any Claim made by me or my agents or successors-in-interest. I understand and agree that under this provision, the Arizona Crappie Association, the State of Arizona, and the United States Government will be indemnified by me whether the Arizona Crappie Association's, State of Arizona's, or the United State Government's potential liability for Claims has risen as a result of the Arizona Crappie Association's, State of Arizona's, or the United States Government's negligence alone, or of co-negligence with me, or the negligence of others.

**3. Assumption of Risk:** I acknowledge that these Events involves certain risks and hazards, including the risk of accidental injury or death, or loss or damage to property, resulting from wild animals, inclement weather, accidents, equipment malfunctions, collisions, falls, drowning, equipment and gear, related injuries (such as fishing hooks in fishing events) or other causes. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE ARIZONA CRAPPIE ASSOCIATION, THE STATE OF ARIZONA, OR THE UNITED STATES GOVERNMENT or others, and assume full responsibility for my participation in these Events.

**4. Good Health & Expertise:** I attest and verify that I am physically fit, am enjoying good health and have sufficient expertise for participation in these Events. I understand that fishing is a physically strenuous activities and that I will be exerting myself during these Events, and that if injured as a result of a heart attack, panic, hyperventilation, etc. That I expressly assume the risk of said injury.

**5. Publicity:** I also irrevocably authorize Arizona Crappie Association, the State of Arizona, the Alamo Lake State Park, and the United States Government, and any assignee to use my name, voice, likeness, biographical information, and/or tips in photography, audio, video, or any other format for publication, advertising, promotional or any other purposes, without restrictions as to changes or alterations from time to time. I understand that I will not be entitled to receive any royalties or other compensation in connection with such use.

**6. Rules:** I take responsibility to know the rules for Arizona Crappie Association's fishing tournament and follow the rules. I ACKNOWLEDGE THAT I HAVE CAREFULLY READ, UNDERSTAND, AND AGREE TO ALL CONDITIONS AND TERMS SET FORTH IN THIS AGREEMENT. I have carefully read this statement. I understand that it is a LEGALLY BINDING AND ENFORCEABLE CONTRACT. I SIGN OF MY OWN FREE WILL and I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

I have read the above rules & regulations and agree to follow said rules & regulations as stated above. I understand that failing to comply with said rules and regulations may result in my team being disqualified from the event and forfeiture of any moneys paid. I also understand that the Arizona Crappie Association, State of Arizona, and the United States Government does not insure or guarantee my or my team's personal safety or the welfare of any personal property. Therefore, I take full responsibility for the safety and actions of my team members and myself and relieve all organizers of the event, fishing tournament, the State of Arizona, the United States Government, the Arizona Crappie Association, and its officers and membership of any and all liability that may become from participating in this event.
